**A BILL**

To protect the integrity of the constitutionally-mandated United States census and prohibit deceptive mail practices that attempt to exploit the decennial census.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Prevent Deceptive Cen-  
5 sus Look Alike Mailings Act”.

1 **SEC. 2. REQUIREMENTS FOR MAIL BEARING THE TERM**  
2 **“CENSUS” ON THE ENVELOPE OR OUTSIDE**  
3 **COVER OR WRAPPER.**

4 (a) MATTER SOLICITING PURCHASE OF A PRODUCT  
5 OR SERVICE.—Section 3001(h) of title 39, United States  
6 Code, is amended—

7 (1) by inserting “; or which bears the term  
8 ‘census’ on the envelope or outside cover or wrap-  
9 per” after “such matter by the Federal Govern-  
10 ment”; and

11 (2) by inserting at the end the following new  
12 paragraph:

13 “(4) In the case of matter bearing the term  
14 ‘census’ on the envelope or outside cover or wrapper,  
15 in addition to satisfying one of the exceptions con-  
16 tained in paragraphs (1), (2), or (3), such envelope  
17 or outside cover or wrapper bears on its face an ac-  
18 curate return address including the name of the en-  
19 tity that sent such matter.”.

20 (b) MATTER SOLICITING INFORMATION OR CON-  
21 TRIBUTION OF FUNDS.—Section 3001(i) of title 39,  
22 United States Code, is amended—

23 (1) by inserting “; or which bears the term  
24 ‘census’ on the envelope or outside cover or wrap-  
25 per” after “such matter by the Federal Govern-  
26 ment”; and

1           (2) by inserting at the end the following new  
2 paragraph:

3           “(4) In the case of matter bearing the term  
4 ‘census’ on the envelope or outside cover or wrapper,  
5 in addition to satisfying one of the exceptions con-  
6 tained in paragraphs (1), (2), or (3), such envelope  
7 or outside cover or wrapper bears on its face an ac-  
8 curate return address including the name of the en-
